### **COOPERATION AGREEMENT**

### between

Damascus University in The Syrian Arab Republic

and

Stat Medical and Pharmaceutical University
"NicolaeTestemitanu" of the Republic of Moldova

Based on the mutual wish of the two universities to further and develop scientific cooperation and academic exchange relations between them, and according to the protocol of cooperation signed between the Ministries of Higher Education in both countries on 20/11/1997.

A scientific cooperation and academic exchange agreement is held between Damascus University represented by its President Professor Doctor Hani MOURTADA and Moldova StateUniversity of Midicine and Pharmacy "Nicolae Testemitanu" represented by its President Professor Doctor Ion Ababii. It includes the following articles:

## ARTICIL 1: FIELDS COVERED BY THE AGREEMENT

Medicine - Dentistry- Pharmacy

**ARTICLE 2: VISITS** 

- A Short- term visits for staff members of the two universities(up to three months).
- 1- The two Universities will exchange visits for members in charge of scientific administration in the presidency of each University and the Faculties with the aim of exchanging information and expertise in the field of higher education and scientific research, and to agree upon the conditions of conducting joint scientific research.

- 2- The two Universities will exchange visits of Teaching Staff members to share expertise and research results as well as lecture and participate in conferences, symposiums, seminars and other scientific activities.
- B- Long term visits for the Teaching Staff members (minimum of four months)
- 1- The two universities will exchange visits for Teaching Staff members to conduct joint scientific research in subjects of common interest. The expenses will be distributed, upon the consent of the two universities, in accordance with the conditions stated in the research project.
- 2- The two universities will receive delegated Teaching Staff members with all expenses covered by the home university in order to carry out scientific research missions .
- 3- The two universities will exchange Teaching Staff members as visiting professors. Expenses are to be considered and organized through formal correspondence in each case individually.

### C- Exchange of students:

Both Universities will exchange students of all academic levels for scientific qualification, training and practical periods in addition to the participation in sport and cultural activities.

## ARTICLE 3: SCIENTIFIC RESEARCH AND POSTGRADUATE STUDIES

The two institutions, by means of the present agreement, are engaged to cooperate within the following proposals in the field of medical training and science:

- 1- Exchange of academics and researchers.
- 2- Exchange of students.
- 3- Exchange of graduates for postgraduate studies.
- 4- Support of mutual interest in international programes of collaboration in acadimic, scientific and cultural areas.
- 5- Exchange of didactic materials (educational methodologies, videos, CDs).
- 6- Joint activities in the filed of university reforming and development of curricula foe medical training.
- 7- Other domains of collaboration convenient for both parties.
  - -The two Universities will implement and develop joint research projects agreed by the two parties who will exchange project related information through direct contact between faculties and departments concerned.
  - Each University will express willingness, upon a request from the other University, to contribute to joint supervision of some of the research theses of postgraduate students within the fields covered by the agreement. The decision of nominating the co-supervisor will be reached in accordance with the present higher education regulations in the respective countries.
- The two universities will express readiness to participate in the examining boards for the defense of some post, graduate theses. The decision of nominating the co-examiners will be taken in accordance with the higher education regulations in force.
- -The two Universities in cooperation with the governmental authorities concerned will organize reciprocal qualification / recognition rules, plus the conditions of study stages and scientific degrees to enable students and graduates of either University to pursue their studies in the other University. The two Universities will take into consideration the provisions of laws in force.
- Each university will provide health and social care for the delegates.

## ARTICLE 4: SCIENTIFIC PUBLICATIONS AND EXCHANGE OF LITERATURE AND SCIENTIFIC DOCUMENTS

- 1- The two universities will exchange literature, publications and periodicals issued by each University as well as Master dissertations and Doctorate theses.
- 2- The two Universities will exchange syllabi, curricula and regulations regarding scientific administration especially in fields included in the agreement.
- 3- The two Universities will exchange specialized references related to postgraduate curricula.
- 4- The two Universities will encourage the publishing of joint research works and scientific articles issued by either University in periodicals and scientific reviews published by the other University.
- 5- The two Universities exchange information and scientific references on different subjects of common interest in the aim of establishing a data bank.

#### ARTICLE 5: EXECUTIVE PROGRAM

Upon signing the present agreement, the two Universities will sign a two year executive program which includes exact specifications of all details required to fulfil the agreement such as duration, number and quality of exchanged visits and joint researches and rules and criteria of selection for students candidates to be exchanged by the two Universities.

Required executive programs are to be set up consecutively during the fulfillment of the agreement.

### ARTICLE 6: JOINT COMMITTEE FOR SUPERVISION AND MONITORING

A joint committee from both Universities will be formed with the main task of drawing up executive programs and supervising the implementation of the present agreement as well as suggesting prospects, methods and means for developing cooperation between the two Universities.

### **ARTICLE 7: FINANCIAL PROVISIONS**

No financial commitment is undertaken by the two universities signing this agreement.

Each program will be individually discussed financially with the exception of the following:

- A- Short-term visits (Article 2, A):
- 1- Home University will cover travel expenses of its delegates (return ticket).
- 2- Host University covers accommodation expenses.
- 3-Ways of covering costs of invitations to participate in university activities are to be agreed upon by formal correspondence.
- B- Long-term visits (Article 2, B):

The two Universities will seek ,within their means, necessary funds to carry on the joint cooperation stipulated in the Article 2B.

### ARTICLE 8: EXCHANGING SUPPORT

The two Universities will offer support to participants in the work program. The support will be given through supplying them with information and facilities required by the cooperation, in addition to solving other problems related to organization.

### ARTICLE 9: RECOGNITION AND VALIDATION

- 1- This agreement will last for four years and will be renewed automatically unless one of the two universities expresses the wish to cancel the agreement through a formal request submitted in writing with at least six months notice before hand.
- 2- New articles can be added, upon the consent of the two universities, to the present agreement while it is still valid.
- 3- This agreement is enforced as from the date of its signing by the Rectors of both Universities.
- 4- After cancellation, terms of the present agreement remain valid in case of delegates already dispatched, according to the agreement, until the end of their designated term. The same applies for research projects and activities till their completion.
