العلماء: ١ diplomaticy

is the management of international relations by negotiation. It is derived from a Greek word a diploma, meaning an official document

العلماء: ١ diplomatic immunity

It refers to special protection afforded all employees of foreign governments who are present in the receiving state

The receiving state may at any time and without explain its decision, notify the sending state that the head of mission of any member of diplomatic staff is persona non grata. The sending state shall either recall the person concerned or terminate his functions

Representing the sending State in the receiving State

Protecting in the receiving State the interests of the sending State and of its nationals

Ascertaining by all lawful means conditions and developments in the receiving State, and reporting thereon to the Government of the sending State

Promoting friendly relations between the sending State and the receiving State

Negotiating with the receiving state

العلماء: ١١ العلمة الدبلوماسية

If a diplomatic agent passes through a third state, the third state shall accord him inviolability and immunities as may be required to ensure his transit or return

العلماء

Third states shall accord to official correspondence the same protection as is accorded by the receiving state

العلماء: ١١ العلمة الدبلوماسية

It assumes that the absence of immunities would lead to a breakdown in the conduct of relations. Immunities are granted because without them agents can't perform their functions

Immunities are granted to diplomats because they couldn't perform their functions unless they enjoy them

السؤال ٤ : ما هي التمتع بالامتيازات الدبلوماسية تجاه الدولة المضيفة؟ ١١ علامة

Respecting the laws of the receiving state. A diplomatic agent should not interfere in the internal affairs of the receiving state

The premises must not be used in a manner incompatible with the functions of the mission

A diplomatic agent shall not practice any professional activity for personal profit in the receiving state

السؤال ٥ : هل يجب أن يكون أعضاء السفارة الدبلوماسية من جنسية الدولة المضيفة أم الجنسية؟ ١١ علامة

In principle they should be of the nationality of sending state. They may not be appointed from among persons having the nationality of the receiving state except with the consent of that state.

السؤال الرابع لدرجة: ٢٢ علامة

Diplomatic agent shall be inviolable. He shall not be liable to any kind of arrest or detention. The receiving state shall treat him with due respect
