Syrian Arab A person who has acquired the Nationality of the Republic according to the ٢٧٦ Decree of ٢٤ Nov ١٩٦٩

الجنسية: ١٠ درجات

It is the legal bond between a person and a state. It carries with : numerous consequences like the right to vote, to own land, and to travel with passport

To be a national means that an individual is a citizen under the terms outlined in the State's legal instruments or that the individual has been granted nationality through a decision made by the relevant authorities.

Those instruments can be a Constitution, a Presidential decree, or a citizenship act



Who is not considered as a national by any state under the operation of its law

A person has to prove a negative: that she has no legal bond with any relevant country

Nationality: is a legal and political bond uniting a person to a particular state ◦ علامات

The status of aliens: their rights and duties. This doesn't necessarily mean their enjoyment of the full rights as nationals ◦ علامات

Conflict of laws: is triggered when a particular situation ١٠ علامات involves a foreign element. It poses three questions: the question of jurisdiction . the question of choice of law. The question of recognition and enforcement of foreign judgments.
